LEAVING A LEGACY

GIVING OPTIONS

LIVING/REVOCABLE TRUST

Set aside assets or income in a trust and name the Library Foundation as the ultimate beneficiary.

LIFE INSURANCE GIFT

Designate the Library Foundation as the beneficiary in a new or existing life insurance policy.

GIFTS BY WILL

Simply name the Library Foundation as a beneficiary in your will, either by a percentage or a specific amount.

IRA GIFT

Add the Library Foundation as a beneficiary to your IRA, or make a direct transfer.

REAL ESTATE

Make a direct gift via transfer of deed or title to the Library Foundation.
